With regret, we announce that former AAFMAA Board Chair, General Robert W. Sennewald (USA, Ret.), passed away on March 17, 2023, at Fort Belvoir, Virginia. GEN Sennewald hailed from St. Louis, was commissioned as a field artillery officer, and had a distinguished 35-year career in the U.S. Army, including combat tours in Korea and Vietnam, and four-star assignments as Commander, US Forces in Korea and later Commander, US Forces Command. From 1995-2006, he served as a board member and later Chair of AAFMAA during a critical period in our Association's history. His contributions to AAFMAA throughout his tenure were consistently focused on our Members and their loved ones. We are grateful for his legacy of service, and we share our deepest condolences with his family.
