## Did You Know?

On June 25, 2019, President Trump signed the [Blue Water Navy Vietnam Veterans Act of 2019](#) into law.

This bill opens eligibility for VA disability benefits to Vietnam Veterans who served at sea and were exposed to chemicals such as Agent Orange. The provisions of the bill are expected to take effect on January 1, 2020, and the Department of Veterans Affairs will publish implementation guidance in the near future.
