



ACT FAST! It's SBP Open Season. You Must Set Your Intention by Nov 1.

The 2023 SBP Open Season is a rare opportunity for Veterans not previously enrolled in SBP or RCSBP as of December 22, 2022 to enroll in the program — and for eligible servicemembers who *are* enrolled to discontinue their coverage.
